



#SummonerBookClub prize draw

Terms & Conditions:

1. This is a prize draw for:
 - I. A signed and numbered limited proof copy of Taran Matharu's SUMMONER: THE OUTCAST – one winner will be selected for each of the fortnight-long individual book clubs (three prizes available in total)
